## Acceptance of offers

1. Complete application form and return with the full booking/security deposit (€300) to validate your application. Please make all payments payable to Cuir na Rasai Teoranta.
2. Payment of the first moiety (room rate x 22 weeks) plus €800.00 (for balance security deposit, electricity and utilities) is due no later than the 21<sup>st</sup> of August at 4pm. If payment has not been received by this date the position will be released for resale without deposit refund. Rooms will be available from Wednesday the 9<sup>th</sup> of September at 3.00pm.
3. 6 equal instalment payments are also accepted. A standing order must be set up for the 5<sup>th</sup> of each month to cover the 6 equal instalments from September to February. There is a once off administration fee of €200.00 payable with the first instalment payment if you wish to pay by the instalment option.
4. Signed Licence agreements will be required before the first moiety payment. (both licensee and guarantor must sign the terms and conditions to validate the licence)
5. Second semester payment (room rate x 16 weeks) is due no later than the 11<sup>th</sup> of December at 4pm. If payment is not received before or on this date the position will be released for re-sale without deposit refund.
6. A full inventory list will also be issued detailing the contents of the apartments. Once you are satisfied that all the items are present, this list must be signed and returned to the accommodations office no later than the 30<sup>th</sup> of September.
7. Students are required to present their college ID to the accommodation office at Cuir na Rasai no later than the 30<sup>th</sup> of September 2026. Your college ID will then be used for security purposes and reference at the apartments.

## Cancellations

In the event where a student has paid the full booking deposit and fails to be offered a place at ATU or for any other reason chooses not to occupy the position offered at Cuir na Rasai, then a cancellation fee of €150.00 will be deducted and the balance refunded. **This refund is strictly subject to all notifications of cancellation of booking/placement to be received in writing or by email from the student/Guarantor on or before 4.00pm the 21<sup>st</sup> August, 2026.**

- There are no booking deposit refunds after the 21<sup>st</sup> August.
- All other refunds after the 21<sup>st</sup> August are at the discretion of the Management.
